Vessels in Port for commercial purpose but not working cargo will be charged at the applicable rate according to origin/destination.

Dock rent will become liable two days following completion of cargo work. In the event of a delay in commencement of a vessel working (with the exception of waiting for a berth or labour) these days will be accumulated within the two period.

Vessels discharging a cargo and subsequently reloading a cargo will be liable for ships dues inwards and outwards at the appropriate rates.
